These times, safety checkpoints, and curfews are itemized on the field trip itinerary attached to this form. Before any student is allowed to go on the field trip, parents or guardians must return this signed permission slip along with the signed itinerary. This will insure that we know that you are aware of the wonderful, exciting opportunities your son or daughter will have as well as the responsibilities they have for acting in a safe and responsible manner.

There is always an element of risk involved in a student's participation in any off campus field trip. By signing this consent form, I recognize that there is a risk my child may be injured during the course of the trip and I hereby release North Shore Central School District from any liability arising out of an injury to my child during the field trip, unless it arises from the districts gross negligence.
